TERMS AND CONDITIONS  
OF  
DETAIL ROOFING AND SHEET METAL

In consideration of DETAIL ROOFING AND SHEET METAL accepting Customer's application for credit and in consideration of any extension of credit by DETAIL ROOFING AND SHEET METAL to Customer and the sale of any goods or services to Customer, intending to be bound legally hereby, Customer agrees as follows:

1. The Customer hereby represents that the information contained herein is true and correct and hereby authorizes DETAIL ROOFING AND SHEET METAL to contact the designated references as well as any or all appropriate credit reporting agencies for information pertaining to the credit worthiness and financial responsibility of the Customer.
2. DETAIL ROOFING AND SHEET METAL may, but shall not be obligated to, extend credit to Customer in its sole discretion and in its sole discretion may modify or withdraw at any time credit terms extended by DETAIL ROOFING AND SHEET METAL to Customer.
3. Terms and Conditions of Sale: Any sale of goods or services by DETAIL ROOFING AND SHEET METAL shall be governed solely by the terms and conditions appearing in the invoice from DETAIL ROOFING AND SHEET METAL or as otherwise established from time to time by DETAIL ROOFING AND SHEET METAL. Any additional or different conditions of sale appearing in Customer's purchase order form or otherwise communicated by Customer are hereby

superseded by DETAIL ROOFING AND SHEET METAL's conditions of sale, unless agreed to in writing by the duly authorized representative of each party.

4. Interest on Late Payment: In the event that any obligation of Customer to DETAIL ROOFING AND SHEET METAL is not paid on the due date thereof, DETAIL ROOFING AND SHEET METAL shall be entitled to charge Customer interest on the full amount of the unpaid obligation at a rate of 1.5% per month (18% per annum), but not in excess of the lawful maximum, commencing from the due date of the obligation and continuing until the obligation is paid in full.
5. Attorney's Fees: In the event DETAIL ROOFING AND SHEET METAL shall determine, in its sole discretion, to use the services of any attorney to collect any past due obligations of Customer, Customer agrees to pay, in addition to the past due obligation, reasonable attorney's fees not to exceed 30% of the unpaid obligation.
6. Governing Law and Consent to Jurisdiction: This Agreement and these Terms and Conditions and any and all dealings between DETAIL ROOFING AND SHEET METAL and Customer shall be construed as having been made or to have taken place in the County of Hamilton, State of Tennessee without regard to the principles of conflicts of laws of any other jurisdiction. In the event of any dispute between DETAIL ROOFING AND SHEET METAL and Customer arising out of or in connection with this Agreement, all actions or disputes shall be brought and tried only in the County of Hamilton, State of Tennessee and violation of this covenant will bar recovery in any other court or jurisdiction.
